Quantro Network is a premium automation ecosystem for disciplined subscribers who want institutional-grade algorithmic trading without manual execution. Through membership, subscribers access a vault of engineered Expert Advisors (EAs) running inside Quantro's secure automation framework. The system includes: Quantro Wallet, EA Vault, and Trading API Portal.








How It Works

01

Purchase Membership Plan

Buy a yearly license.

02

Fund Quantro Wallet

Add funds (USDT, BTC, etc.).

03

Select EA

Pick from the EA Vault (Atlas or Zenith).

04

Activate License Key

12-month EA license tied to your ID.

05

Monitor Execution

live metrics via the Trading API.

06

Withdraw / Adjust

Follow defined withdrawal rules.



The EA Vault

Each EA is built for precise execution and real-time adaptation

Quantro Atlas

hedging + scalping; microreturns and adaptive risk balancing. (As provided: Quantro Atlas yields 1% daily.)

Quantro Zenith

hedging, scalping & HFT principles for rapid markets. (As provided :Quantro Zenit yields 1.8% daily.)

Both EAs operate under constant risk supervision and system health monitoring, ensuring consistent performance and safety.





01

Trade Frequency

EAs trade up to 6 times a day.

02

Operational Days

Automated 6-day cycle with health checks before sessions.

03

Monitoring

Real-time telemetry, session logs, and version tracking.



Quantro Wallet

The QN Wallet is the internal balance layer that powers automation

Audit

Every movement is recorded and exportable.



Funding

Top up inside the platform.

Control

Withdrawals processed under platform rules (one standard withdrawal per day).

Security

Multi-layer encryption and balance segmentation.



Withdrawal & Lockup Rules

Seed capital = \$1,000. User withdraws before 75 days

- Early withdrawal penalty (15%): 1,000 x 0.15 = \$150.
- Remaining after penalty: 1,000 <u>150 = \$850.</u>
- Withdrawal fee (2%) on the remaining: $850 \times 0.02 = 17 .
- Net amount user receives: 850 17 = \$833.

Transparency is not optional at Quantro Network, it's the foundation of our system integrity.



Seed capital lock

Your seed capital (the money you put into the bot) stay actively traded for 75 days and if you want to withdraw before 75 days active trade its incurs a 15% deduction.

Early withdrawal penalty

If you withdraw seed capital before 75 days, a 15% penalty applies. This penalty helps protect the platform and other subscribers.

Minimum withdrawal

The Minimum withdrawal you can request is \$20.

Withdrawal fee

Every withdrawal has a 2% processing fee. This covers network and processing costs.

Why these rules exist

They protect liquidity and keep the bots working well. They stop short-term abuse and make results predictable for all members.

live metrics, drawdown stats, and runtime diagnostics for every subscriber.



Core tech strengths

- Low-latency routing and adaptive positioning engine.
- Hedging layer for market-neutral exposure.
- Scalping microstructure for minimal slippage.
- Telemetry hub streams anonymized performance data to our Expert Advisor API.





Transparency & Reporting

Quantro Networks gives members full, clear access to what the EAs do. Every trade, session, and system change is visible so subscribers can check performance, compare versions, and export data for their own review. This makes the platform honest, auditable, and easy to use.

Transparency is core infrastructure, not optional

- Live execution sessions and full trade records (see trades as they happen).
- EA version info and uptime data (which bot version ran and when).
- Historical session summaries and runtime snapshots (past performance at a glance).
- Exportable logs for independent analysis (downloadable CSVs or reports).



- Onboarding modules: setup, license activation, wallet management.
- Education on algorithm logic, risk, and EA behavior.
- Periodic briefings and transparency reports for community assurance.
- Dedicated support for verified subscribers.

Quantro Network integrates a structured, performance-based referral framework designed to reward transparency, leadership, and sustainable network growth. The system operates within a 3-tier corporate model to ensure clarity and compliance.

Direct Referrals

Earn instant rewards for every new verified subscriber you personally refer to Quantro Network. Once the membership activation is complete and EA license is successfully activated your referral reward is automatically credited to your Quantro referral Wallet.

Team Growth Overrides

Receive ongoing override commissions generated from the activity and engagement of your first-level recruits and their direct referrals. This layer encourages teamwork, mentorship, and consistent network expansion

Leadership Bonus

Leaders who actively manage and sustain high-performing teams qualify for additional leadership bonuses. These performance-based incentives recognize strategic guidance, community building, and sustained results.



Referral Earnings System

Users can share their referral link, create their own network of subscribers I, and earn commissions. All benefits are percentage-based and directly commensurate to the individual subscription record made by your downline.

Commissions are calculated for each active deposit activity made from an external source.

Quantro Network Team Volume Compensation Structure And Status When your total team subscription record turnover reaches a certain amount, you will receive a one-time direct bonus reward and a some stage you will get daily residual earnings credited weekly to your account. We give the direct bonus award to our valued subscribers as a way of recognizing their efforts in creating and nurturing their teams. You become eligible for these bonus awards once your team's deposit turnover surpasses certain milestones, as shown in the table below.

One of the major criteria to achieve each milestone is 35% of team volume must come from your Level 1 to achieve each status.

Roadmap

Monitoring & Mobile

- Add deeper live signals (latency, fills, drawdown alerts) so you can see exactly how bots perform.
- Cleaner dashboard with simple charts and quick filters for fast checks.
- Mobile view + push alerts so you can monitor and act from your phone.
- What this means: You'll be able to spot issues and check performance in seconds anywhere.

Scale & Integrate

Q1

- Bigger EA catalog with more risk choices.
- Enterprise tools: team dashboards, policy controls, white-label options.
- API access for verified partners and institutions.
- Future Integration of live trading signal and live staking pools (Coming soon)

Test & Combine

- Strategy sandbox: run ideas on past data without risking funds.
- Multi-EA stacking: run two or more EAs together with automatic risk sharing.
- Smart alerts for key trade or health events.
- What this means: Try new strategies safely and combine bots to smooth returns.

Insight & Funding

- Deep analytics: trade-level KPIs and clear performance breakdowns per EA.
- Algorithm reports that show when and why a bot worked.
- More funding options (extra crypto rails, easier on-ramps).
- What this means: Understand results clearly and fund accounts the way you prefer.
